

# BUHL PARK PHOTOGRAPHER REGISTRATION

A \$50 /year fee applies and must be paid/turned in at least 3 days prior to your first session.

The following types of photography sessions requires a Photographer Permit issued by Buhl Park:

- \*Wedding
- Engagement/Proposals
- Maternity/gender reveal
- Lifestyle (Newborn/child/family)
- School sports/Senior pictures
- Holiday portraits
- Professional and group headshots/portraits
- Videography

## PHOTOGRAPHER POLICY

Buhl Park is a privately run organization that reserves the right to require a Photographer Permit for professional and semi-professional photoshoots and videography. A professional or semi-professional photographer is defined by Buhl Park as taking photographs and/or video of clients while on Buhl Park property. The list on page one defines the type of photoshoots that requires such permit throughout the year.

\*If your client has rented a Buhl Park facility, you are not subject to a fee. However, you are still required to register and pay the yearly fee if you have other clients throughout the year that do not rent a Buhl Park facility.

The Buhl Park Corporation has the sole discretion to determine to deny the issuance of any Photographer Permit, group or individual whose proposed activity is illegal or poses a threat of damage to the Casino or Buhl Park property or injury or harm to the participants at the function. Violation of any of the conditions of the Buhl Park Photographer Policy or of any laws of the Commonwealth of Pennsylvania or ordinances of the City of Hermitage during the use of the property shall be grounds for immediate removal. Any applicable cleaning fees, denial of future use of Buhl Park, or criminal charges may also result.

**REGISTRATION MUST BE TURNED IN TO CASINO OFFICES AT LEAST 3 DAYS PRIOR TO FIRST SESSION.**

*The applicant and the applicant's group, shall indemnify, defend and hold Buhl Park, it's elected and appointed officials, agents, employees, and volunteers harmless from all liabilities, claims, judgments, demands, and costs arising out of or resulting from applicants, applicant's group or their invitees' use of Buhl Park's grounds and adherence to all rules included in the Photographer Policy.*

*I have read and agree to abide by the regulations established for use of Buhl Park's facilities. I agree to be solely and completely responsible for the condition of the grounds and to leave them in the condition in which they found it, without damage. I agree to promptly reimburse Buhl Park for all damages.*
